Steering Committee meeting #11 communiqué

30 November 2020

The National First Peoples Gathering on Climate Change (NFPGCC) aims to celebrate, learn from and enhance First Peoples-led climate change action.

The theme of this event is 'Catastrophic extreme weather events: a changing world'.

The eleventh meeting of the NFPGCC Steering Committee was held online on 30 November 2020.

Attendees

Update from the organising committee

Sophie Schmidt has joined the Organising Committee as a communication advisor to provide advice and support to the communication sub-committee.

The Organising Committee has contacted a couple of potential Steering Committee members to replace those who have resigned from NT, SA and WA.

The first round of invitation was sent on 30 November, the invite list included the attendees of the 2018 National Indigenous Dialogue on Climate Change. Once nominations from the first round of invites have been received, a second list of invitees will be developed to fill the remaining spaces.

Consent processes

Following feedback on the draft consent form at the last meeting, a revised version in the structure of the AIATSIS participant information and consent form has been drafted with the Co-Chairs for review of the Steering Committee. The new draft consent form is still based on the form developed at the 2018 National Indigenous Dialogue on Climate Change. The Steering Committee provided feedback that some of the terminology used in the consent form needed to be simplified. It was decided that the consent form will be sent to nominees to read and talk with their group if needed prior to the Gathering, and an explanation and discussion with the Gathering participants would occur on the first morning of the Gathering.

The Steering Committee also agreed that the scientists should sign a code of conduct form based on the ['Co-design, cross cultural communication and](#)

Draft agenda

The Steering Committee reviewed and updated the program. Volunteers were suggested to further develop sessions in the program. A program sub-committee meeting will be held in the next couple of weeks to progress the program development.

Face-to-face meeting

The Steering Committee agreed to schedule a face-to-face meeting early in the new year to consider the nominations received in the first round and progress planning. The location and date are to be confirmed.

Next meeting

The next Steering Committee meeting will be on 14 December 2020, via videoconference.
